# Bullying and Harassment Policy and Procedures

## **Rationale**

This policy refers to how the College will manage bullying and harassment. At Summerland Christian College we seek to build a safe, positive and caring Christian environment in which we acknowledge that each human is uniquely created by God and therefore of immense value. We aim to reduce the incidence of bullying and harassment and work positively with students and families to grow strong and resilient individuals to positively impact the world.

This Policy and the associated Procedures are based on the 5 Core Values of Summerland Christian College.

## 1. Christ Centred.

## **Bullying Definition**

The national definition of bullying for Australian schools says:

Bullying is an ongoing and deliberate misuse of power in relationships through repeated verbal, physical and/or social behaviour that intends to cause physical, social and/or psychological harm. It can involve an individual or a group misusing their power, or perceived power, over one or more persons who feel unable to stop it from happening.

Bullying can happen in person or online, via various digital platforms and devices and it can be obvious (overt) or hidden (covert). Bullying behaviour is repeated, or has the potential to be repeated, over time (for example, through sharing of digital records).

Bullying of any form or for any reason can have immediate, medium and long-term effects on those involved, including bystanders. Single incidents and conflict or fights between equals, whether in person or online, are not defined as bullying.

Behaviours that do not constitute bullying include:

- mutual arguments and disagreements (where there is no power imbalance);
- not liking someone or a single act of social rejection;
- one-off acts of meanness or spite; or
- isolated incidents of aggression, intimidation or violence.

However, these conflicts still need to be addressed and resolved using the College Behaviour Management Policy and Procedures.

## **Proactive Strategies**

At Summerland Christian College we implement a range of strategies to minimize bullying. These strategies include:

- 1. Encouraging caring and loving behaviours in students, and teach relevant Biblical principles;
- 2. Active supervision of students duty in order to reduce these incidents of bullying;
- 3. Regular staff and student information sessions focusing on bullying behaviour and management strategies; and
- 4. Encouraging parents to contact the College immediately if they suspect bullying and to work collaboratively with the College to resolve issues.

## **Responding to Bullying**

Our College processes for managing bullying and harassment are key to providing a safe and supportive College environment. Responding to incidents in a constructive, supportive and timely manner is critical. It is vital that our response includes restoring relationships and teaching about appropriate ways to relate to others in their responses.

Parents or other carers are often the first person that a child tells about bullying at school. Sensitive and respectful responses by parents can make a difference. Parents working together with the school is the best way to stop the bullying from happening again.

Ensuring that our students know how to report bullying can reduce the chance of bullying going unreported or students being reluctant to tell someone. Encouraging students to report bullying helps our College gain a more accurate picture of bullying in their community and provide help where it is needed.

### **College Procedures**

- 1. All incidents will be treated seriously;
- 2. All students involved are to be interviewed;
- 3. Where possible students will provide a written statement;
- 4. The Head of School will determine and implement an appropriate Intervention Plan:
- 5. The Intervention Plan will be communicated with all stakeholders and stored on Sentral;
- 6. Support and counselling for those involved will be provided if requested or determined in the Intervention Plan; and
- 7. The situation will monitored over the following two weeks.
- 8. If the bullying continues following the implementation of the Intervention Pan the child's enrolment will be cancelled.
